The Lessee agrees to waive all claims and hold harmless the Sibley County Agricultural Association, and its representatives, for any damage to the property from [_____] until it is returned to the Lessee [~APRIL].

- Lessee will provide their own insurance at their own expense during the time the property is stored at the *Sibley County Fair Grounds* in Arlington Minnesota.
- SCFB reserves the right to designate the building the property will be stored in and move if deemed necessary.
- SCFB reserves the right to inspect all units for prior damage.
- Lessee may store property from October to April(date TBD, weather permitting) at a cost of \$ 1.50 per square foot.
 - *If picked up late, a **\$1.00 per sq. ft. per MONTH** will be charged before pick up.*
- Service fee of \$30.00 will be charged on returned checks, Minnesota Statutes, section 604.113, subd. 2 (a) and section 609.535, subd. 2a.
- There will be no allowing an early release from storage.
 - *If completely unavoidable & deemed reasonable by Fairboard; there shall be no refund and subject to additional fee; situational based.*
