- The Sibley County Board reserves the right to inspect all units for prior damage.
- Lessee may store property from October to April<sub>(date TBD, weather permitting)</sub> at a cost of \$ 1.50 per square foot. *If picked up late, a **\$1.00 per sq. ft. per MONTH*** will be charged before pick up.
- DUE TO ABUSE OF OUR ALLOWING EARLY OUTS, **WE WILL NO LONGER PERMIT IT.** If completely unavoidable & deemed reasonable by Fairboard; there shall be no refund and subject to additional fee; situational based.
